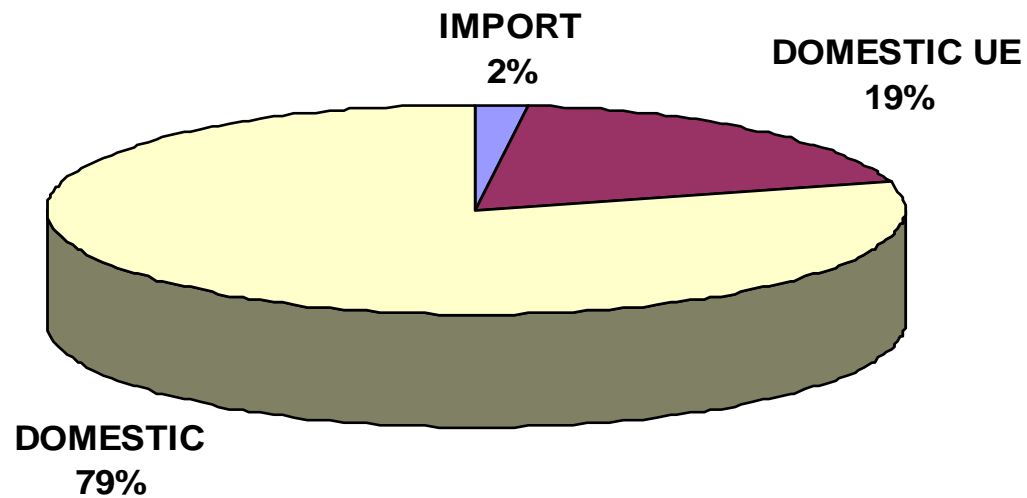

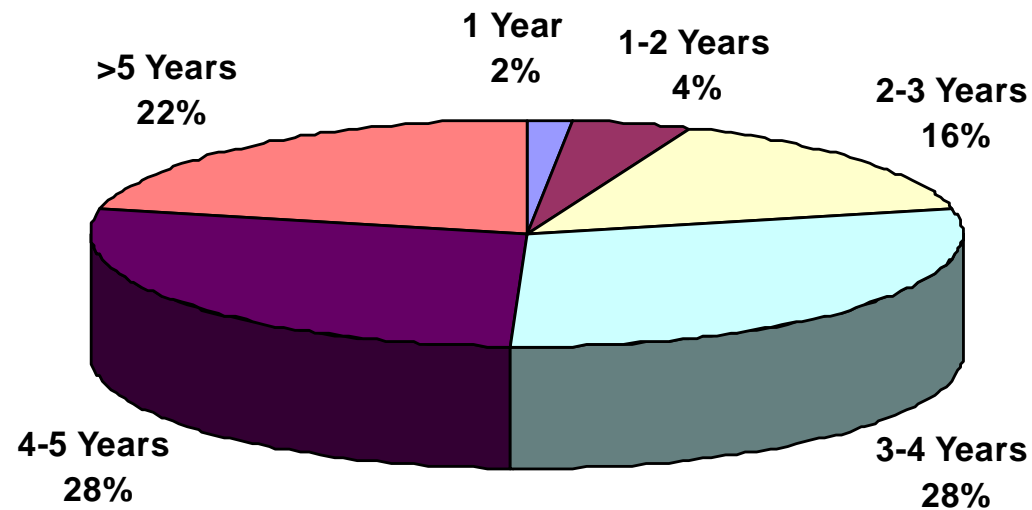

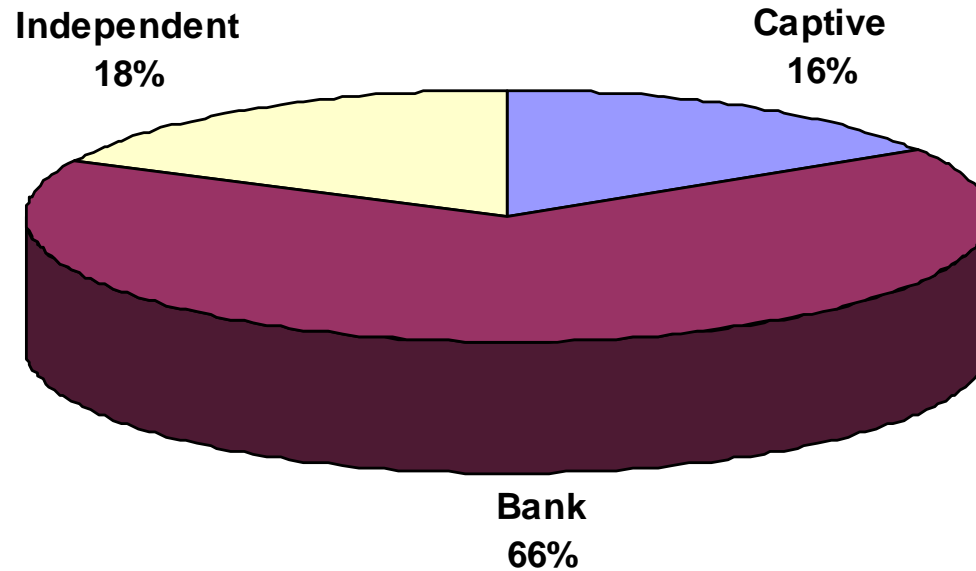

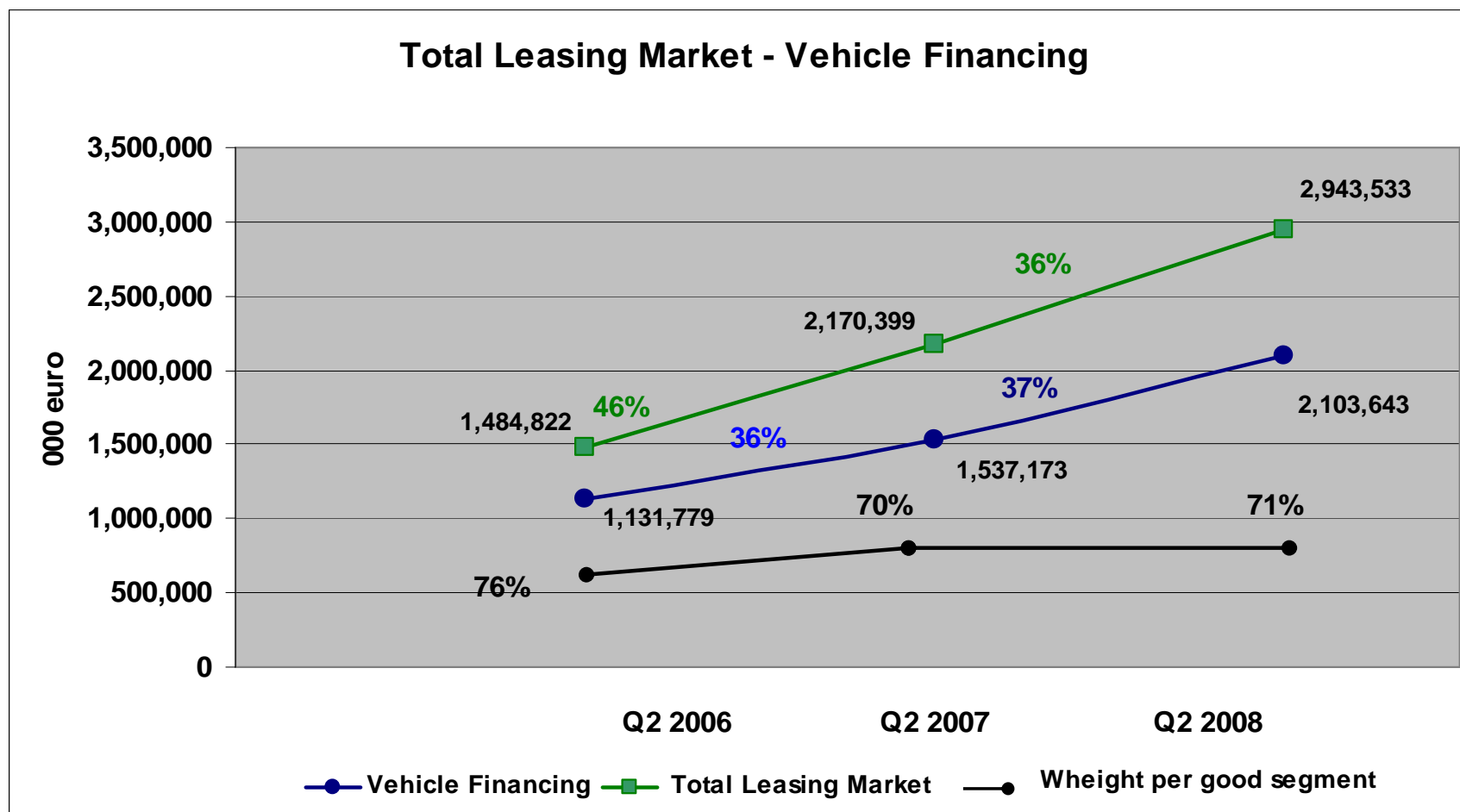

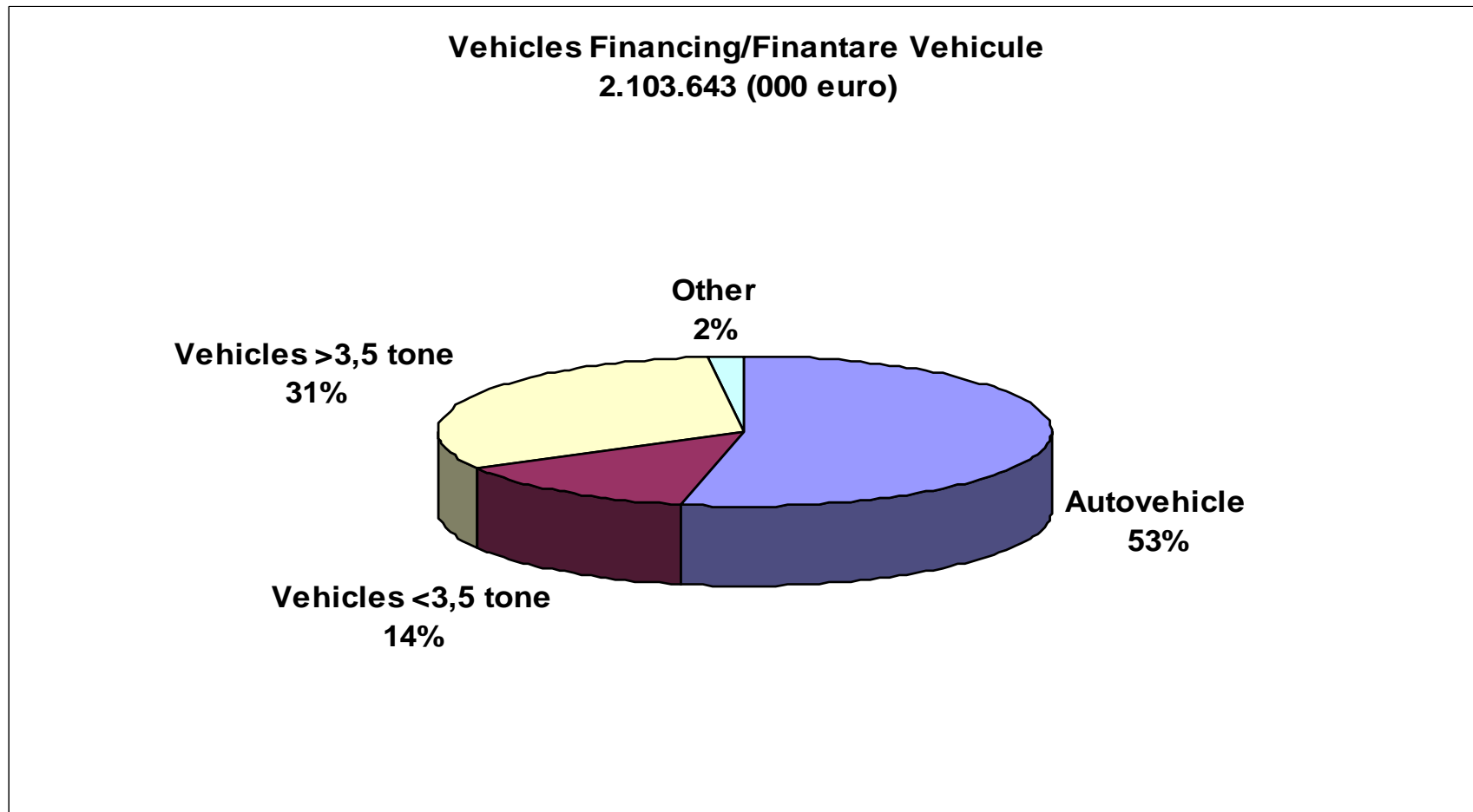
Total Asset Value by Type of Lessors/ Functie de tipul finantatorului

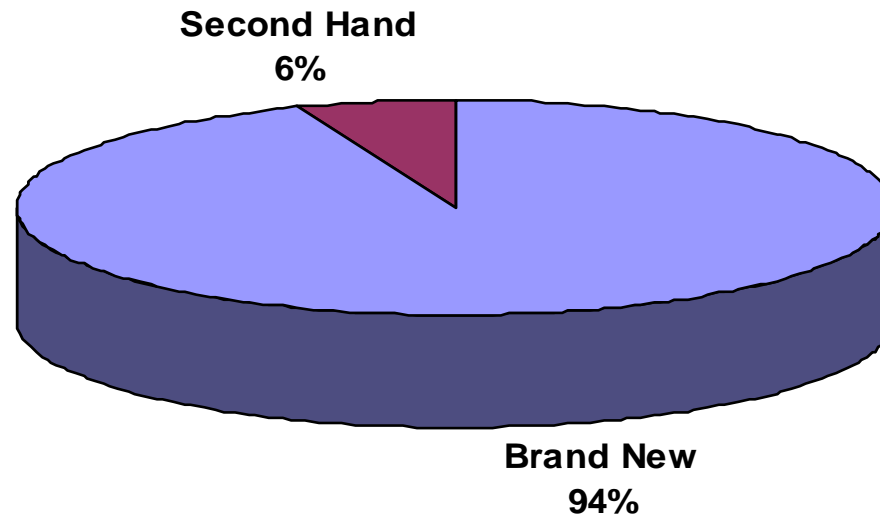

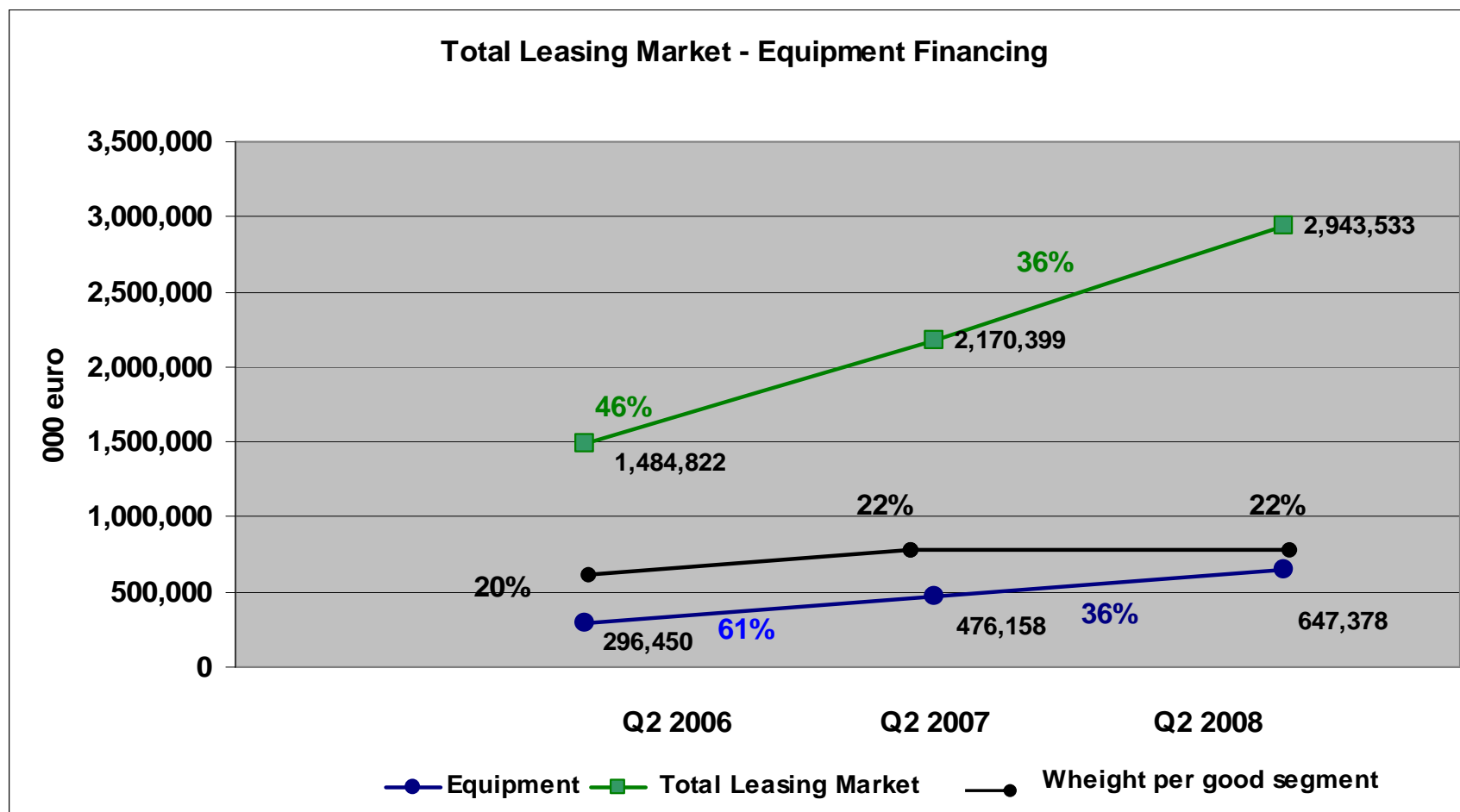

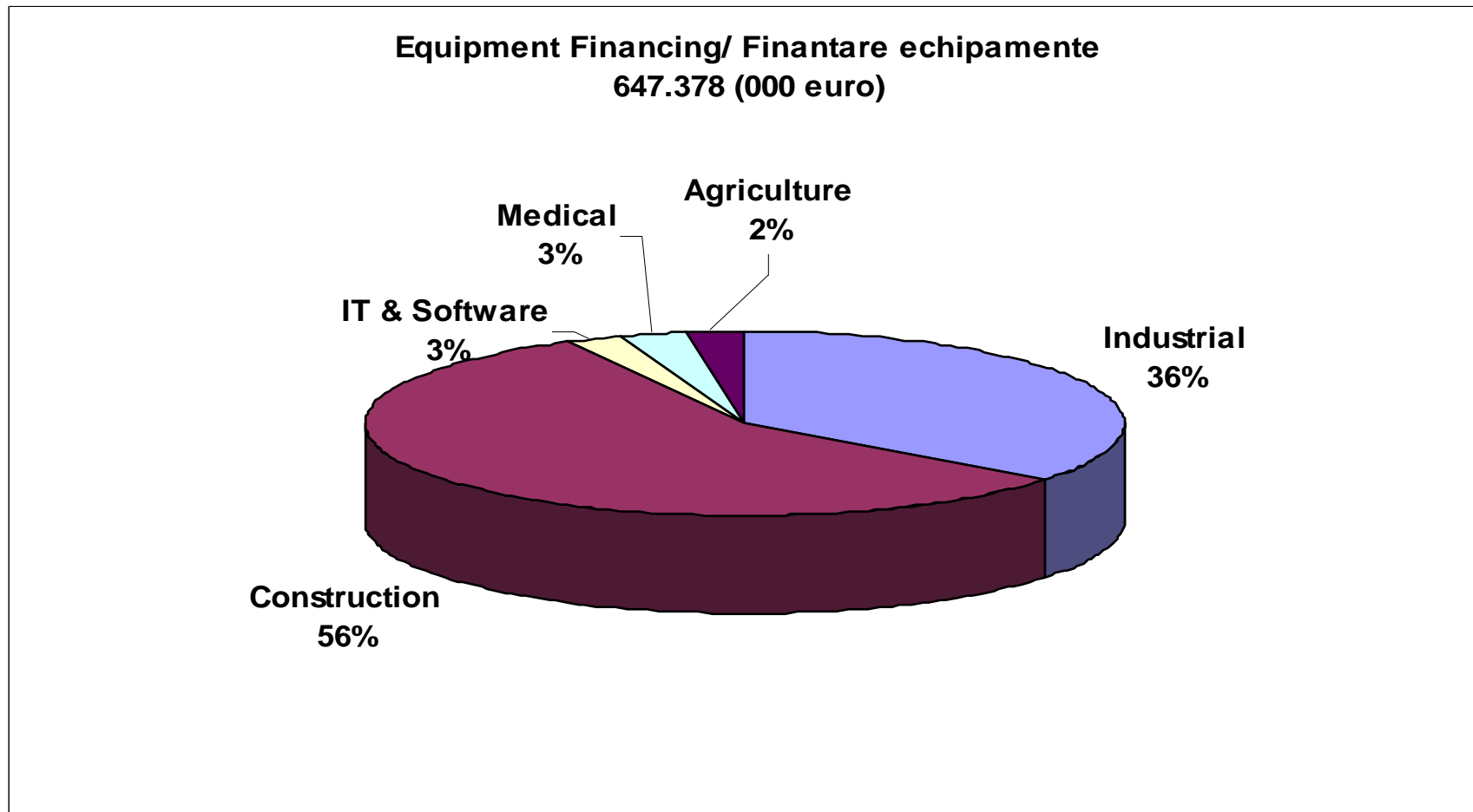
Vehicles Financing by Acquisition Type/Finantare Vehicule noi versus

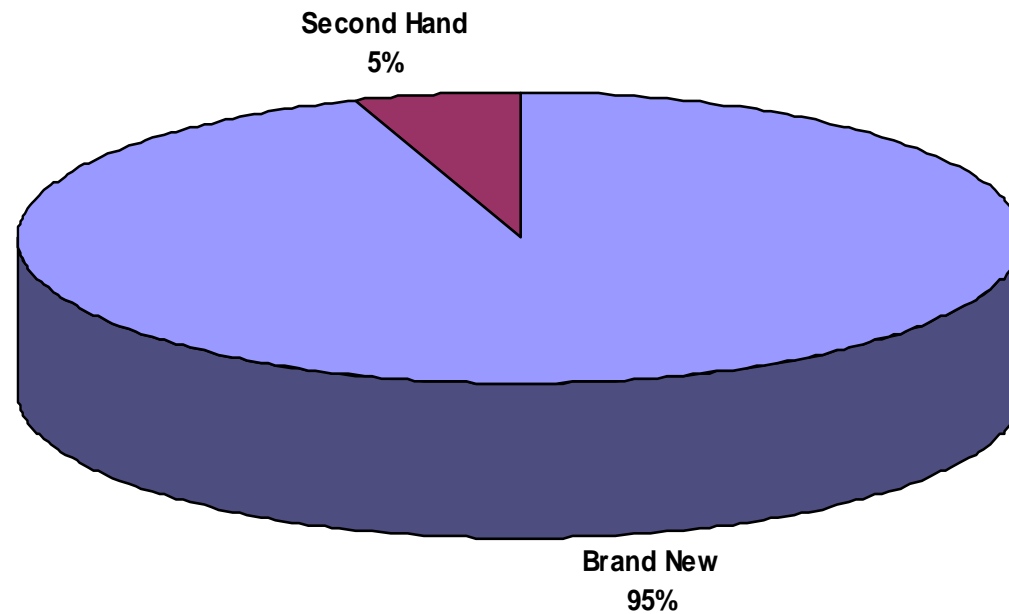

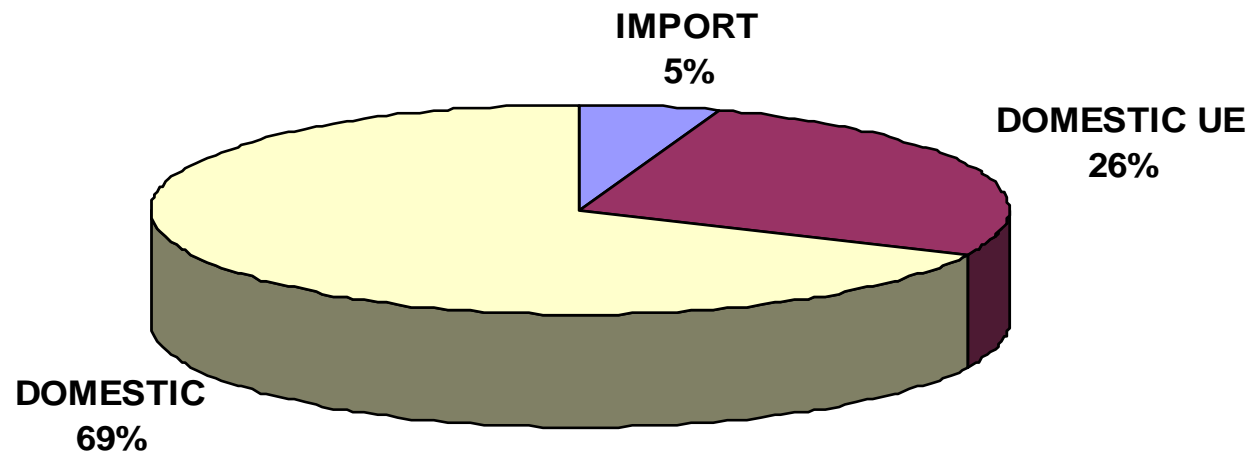
Equipment Financing by Acquisition Type/ Finantare echipamente noi versus "second hand"

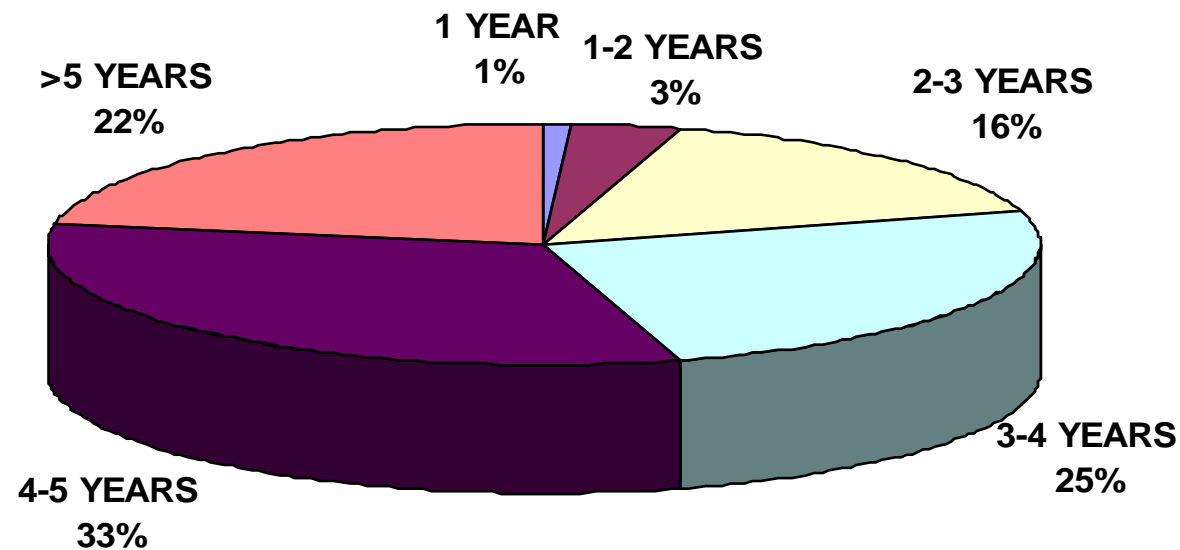

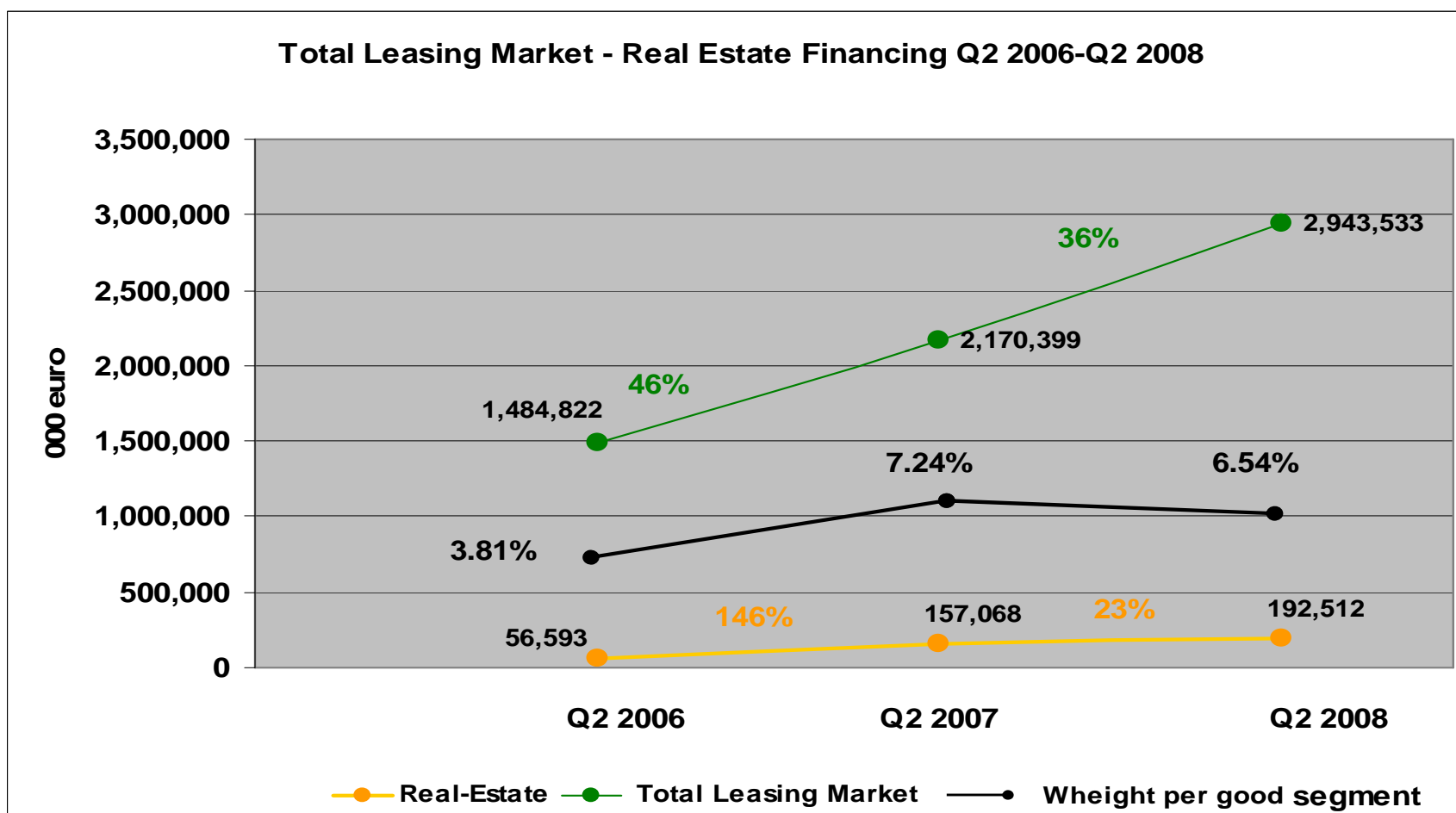

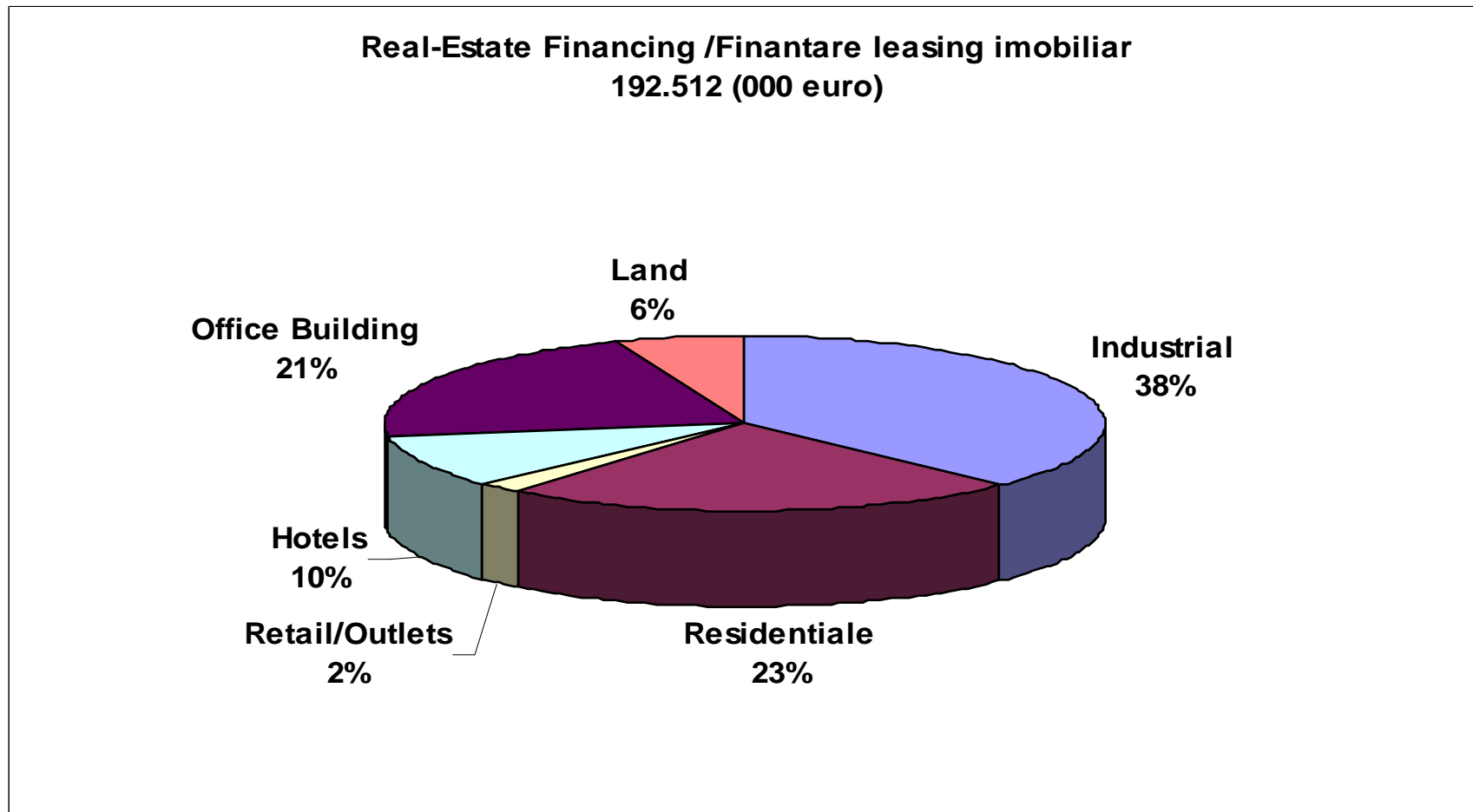
Equipment Financing by Origin /Finantare echipamente in functie de durata contractului

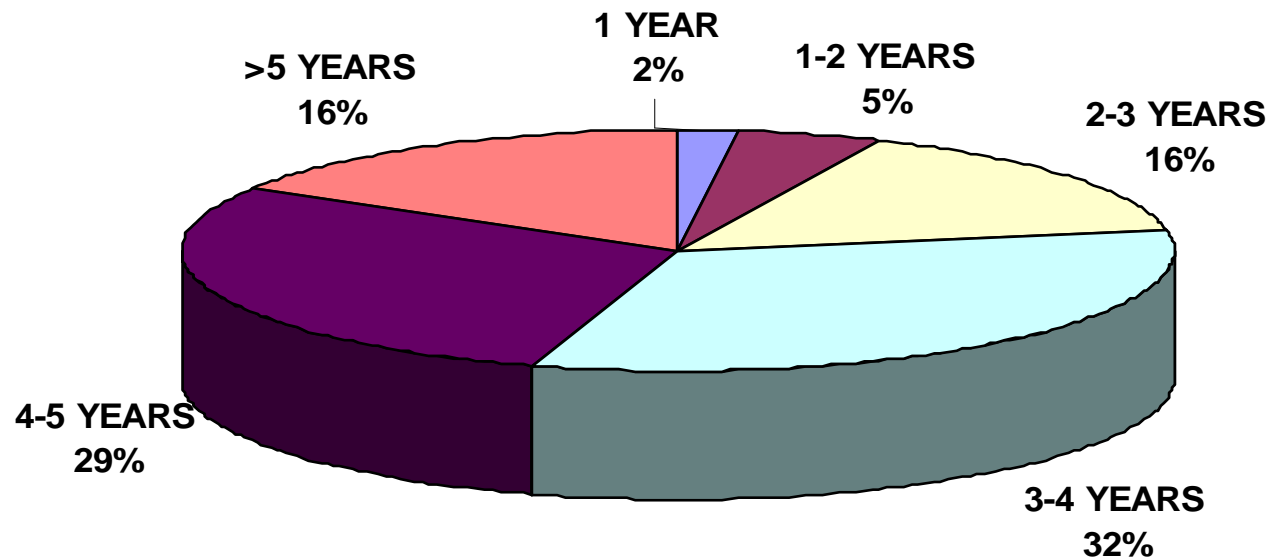
